

## Form and Instructions for Study Packets Order or Pesticide Short Course Registration

### To order a study packet:

1. Know which *category* of restricted use pesticide examination you should study for. Read the note on this page under Categories of certification examinations.
2. Learn which study packet or packets to order. Read the note on page 2 Which study packets to order?
3. Fill in the box on page 3: Form for ordering STUDY PACKETS for Examinations for restricted use pesticide certification.
4. Then add the sub-total to your TOTAL on page 4 and fill in the appropriate boxes.
5. Send us your payment with your completed form. Read the note on page 2 under Sending your payment and form.

**Categories of certification examinations**—Before you mark your order for a study packet on page 3, find out which category of restricted use pesticide certification exam matches the kind of work you do with pesticides. *Do not guess!* You could waste your time and money if you study for an exam that does not match. Ask about the categories of certification examinations by calling one of these telephone numbers for the Hawaii Department of Agriculture’s Pesticides Branch:

You may register for a short course even if you don’t order a study packet. But the short course does not cover all of the topics in the Hawaii Department of Agriculture’s examination for restricted use pesticide certification. So if you want to prepare for the examination, you should also study the study guides in the study packets. **Which study packets to order?**—First, learn which examination category or categories you want to study for. For help, you can call one of the telephone numbers listed on page 1 under Categories of certification examinations. (*Do not guess!* You could waste your time and money if you study for an exam for a certification category that does not match the kind of work you do with pesticides.) Then, in the list below, find your category or categories and read the recommendations about getting the matching packet or packets of study guides. Use the form on page 3 to order printed versions of study packets.

For the <i>Private 1 General Agricultural</i> pest control exam, get the Basic study packet and the Private 1,2,3 study packet.
For the <i>Private 2 Agricultural Fumigation</i> pest control exam only, get the Private 1,2,3 study packet.
For the <i>Private 3 Agricultural Chemigation</i> pest control exam only, get the Private 1,2,3 study packet.
For the <i>Commercial 1a Agricultural Plant</i> pest control certification exams, get the Basic study packet for the Core portion of the exam and the Commercial 1a study packet for the Commercial 1a portion of the exam.
For the <i>Commercial 1b Agricultural Animal</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 1b study packet for the Commercial 1b portion of the exam.
For the <i>Commercial 2 Forest</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 2 study packet for the Commercial 2 portion of the exam.
For the <i>Commercial 3 Ornamental and Turf</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 3 study packet for the Commercial 3 portion of the exam.
For the <i>Commercial 4 Aerial</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 4 study packet for the Commercial 4 portion of the exam.
For the <i>Commercial 5 Aquatic</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 5 study packet for the Commercial 5 portion of the exam.
For the <i>Commercial 6 Right-of-Way</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 6 study packet for the Commercial 6 portion of the exam.
For the <i>Commercial 7a Fumigation</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 7a,b,c,d,e study packet for the Commercial 7a portion of the exam.
For the <i>Commercial 7b Termite</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 7a,b,c,d,e study packet for the Commercial 7b portion of the exam.
For the <i>Commercial 7c General</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 7a,b,c,d,e study packet for the Commercial 7c portion of the exam.
For the <i>Commercial 7d Institutional</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 7a,b,c,d,e study packet for the Commercial 7d portion of the exam.
For the <i>Commercial 7e Vault fumigation</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 7a,b,c,d,e study packet for the Commercial 7e portion of the exam.

For the <i>Commercial 7f specialty: TBT</i> exams, get the Basic study packet for the Core portion of the exam and the Commercial 7d–TBT study packet for the Commercial 7f specialty: TBT portion of the exam.
For the <i>Commercial 7f specialty: Wood Treatment</i> exams, get the Basic study packet for the Core portion of the exam and the Commercial 7f specialty: Wood Treatment study packet for the Commercial 7f specialty: Wood Treatment portion of the exam.
For the <i>Commercial 7f specialty: Chlorine Gas</i> exam, get the Commercial 7f specialty: Chlorine gas study packet.
For the <i>Commercial 9 Regulatory</i> pest control exams, get the Basic study packet for the Core portion of the exam and the Commercial 9 study packet for the Commercial 9 portion of the exam.
For the <i>Commercial 10 Demonstration, Research and Instructional</i> pest control exam, get the Basic study packet for the Core portion of the exam and the Commercial 10 study packet for the Commercial 10 portion of the exam.
For the <i>Commercial 11 Chemigation</i> pest control exam only, get the Commercial 11 Chemigation pest control study packet.
