Appointed by Secretary of Agriculture Vilsack as an organic farmer member of the National Organic Standards Board (NOSB) beginning January 25, 2011, for a five-year term, Colehour Bondera of Honaunau, Hawaii is always open to hear the voices and opinions of other Hawaiians. From other farmers to all parts of the Hawaii organic industry, Colehour seeks to hear and will listen to you all!

Colehour and his wife Melanie Bondera live with their two children on a five-acre farm, which is half Kona coffee and the remainder is diverse over-story trees (primarily avocados), non-coffee mid-story trees (such as cacao, citrus, papaya and tamarillo), and under-story crops including white pineapples and vegetable gardens.

The 15-member National Organic Standards Board is made up of organic farmers and growers, handlers and processors, retailers, environmentalists and conservationists, consumer and public interest advocates, a scientist, and a USDA-accredited certifying agent. The NOSB advises the Secretary of Agriculture on allowed and prohibited substances in organic production and handling and other issues related to the implementation of the Organic Foods Production Act.

Mr. Bondera currently serves on the Crops Committee and the Livestock Committees. The various committees (there are six in all) meet regularly throughout the year, and twice a year the whole NOSB comes together and hears public commentary and subsequently as a whole makes decisions about Committee recommendations.
